Re: Notification of Central Withholding Agreement (CWA) for Sophia Stel p/k/a Sophia Stel.

Dear Frank Page,

The Internal Revenue Service has entered into a Central Withholding Agreement with Sophia Stel p/k/a Sophia Stel.

A CWA is an agreement entered into by the non-resident alien (NRA) athlete or entertainer, a designated withholding agent and an authorized representative of the Internal Revenue Service. The CWA is for a specific tour or series of events listed in Exhibit A.

The designated withholding agent is required to withhold and pay withholding tax according to the terms of the CWA.

Each venue or promoter listed in Exhibit A are not required to withhold on the payments made for the dates listed on Exhibit A and won't have any Form 1042, *Annual Withholding Tax Return for U.S. Source Income of Foreign Persons*, reporting requirements on payments made for those events for the above-listed NRA.
